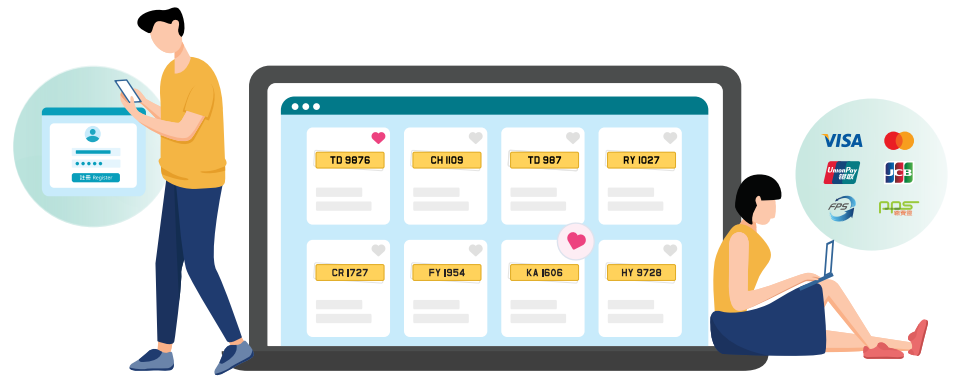

「拍牌易」是由運輸署開發的全新智能拍賣平台，提供更有效率、便利及貼心易用的一站式的車輛登記號碼拍賣服務。

E-Auction is a brand new intelligent auction platform developed by the Transport Department. It offers a comprehensive and user-friendly vehicle registration mark auction service that is more efficient, convenient, and customer-oriented.

注意事項 Notice:

拍牌易只適用於普通車輛登記號碼。至於以「HK」或「XX」為首的登記號碼、特殊登記號碼和自訂車輛登記號碼，則沿用現時現場舉牌競投的方式拍賣。
E-Auction is only applicable to the auction of Ordinary Vehicle Registration Marks. Other registration marks starting with "HK"/"XX", special vehicle registration marks and personalized vehicle registration marks will continue to be auctioned in physical auction venues by paddle bidding method.
