

須知事項

1. 設有可延伸架空結構車輛安裝過高警示系統供應商名單（名單）內的服務提供者（供應商）曾經為車輛提供過高警示系統的設計及安裝服務。名單的資料是由供應商自願提供。本名單所載資料按相關供應商所提供的資料編製，旨在提供予服務使用者作一般參考用途。本名單及其所載之資料並非詳盡無遺。
