## 核實「電子聯絡方式」

根據法例，申請人遞交各項駕駛執照或車輛牌照服務申請時，必須提供一個可藉短訊方式聯絡申請人的香港流動電話號碼或藉電子郵件方式聯絡申請人的電郵地址，作為電子聯絡方式。有關電子聯絡方式必須於遞交申請前三個月內經運輸署網上牌照服務或指定網上平台，以一次性密碼核實，詳情請參閱[運輸署網頁](#)，或掃描此二維碼。

## 車輛(的士除外)過戶的法定要求

根據法例，登記車主(「舊車主」)須在車輛過戶後72小時內，向本署車輛記錄辦事處遞交已填妥、並由舊車主及新車主雙方已簽署的「車輛過戶通知書(的士除外)」的副本(即表格TD25第3頁)；而新車主則須在車輛過戶後72小時內，向本署牌照事務處遞交已填妥、並由舊車主及新車主雙方已簽署的「車輛過戶通知書(的士除外)」的正本(即表格TD25第1頁)及所需文件與費用，以完成車輛過戶程序。舊車主應確保新車主於車輛過戶後72小時內向運輸署遞交上述「車輛過戶通知書(的士除外)」的正本以完成辦理車輛過戶手續，否則車輛過戶手續並未完成。在運輸署完成辦理車輛過戶手續前，由於車輛仍在舊車主名下，舊車主仍須繼續承擔該車輛所招致的所有法律責任。

## 在車輛登記文件簽署及蓋印規定

車輛登記文件(以下簡稱為「牌簿」)上必須載有登記車主簽署，而當登記車主遞交有關的牌照申請時，申請表格上的簽署必須與牌簿上的簽署相符；如以公司/機構為登記車主，牌簿必須載有由該公司/機構所指定獲授權人士的簽署並加蓋該公司/機構的印章，而申請表格上的印章與牌簿上的印章必須完全相同，否則運輸署將不會處理有關的牌照申請。

## 地址證明要求

於遞交牌照服務申請時，必須連同最近三個月內發出的地址證明文件正本或副本，否則運輸署可以根據有關法例暫停處理有關申請。[\[請參閱可接納的地址證明\]](#)

## 更改地址或電子聯絡方式

根據法例，駕駛執照持有人或登記車主的地址或電子聯絡方式如有改變，須在72小時內通知運輸署。任何人無合理辯解而違反此規定，即屬犯罪，一經定罪，可處第1級罰款。你可透過[政府一站通](#)、遞交指明的表格(「更改個人資料或車輛資料通知書」)或以書面方式，連同新地址的證明文件(如適用)通知運輸署有關地址的更改。

## 注意事項 NOTES FOR ATTENTION

- (1) 電子聯絡方式 - 申請人遞交各項駕駛執照或車輛牌照服務申請時，必須提供一個可藉短訊方式聯絡申請人的香港流動電話號碼或藉電子郵件方式聯絡申請人的電郵地址，作為電子聯絡方式。有關電子聯絡方式必須於遞交申請前的三個月內經運輸署網頁核實，否則本署可暫停處理該申請。詳情請參閱運輸署網頁 ([www.td.gov.hk](http://www.td.gov.hk))。如你同時提供香港流動電話號碼及電郵地址，則優先以香港流動電話號碼作為電子聯絡方式。關於電子聯絡方式的收集目的和獲轉交資料的部門/人士，請參考「關於你個人資料的說明」。具體而言，運輸署、香港警務處、其他政府部門、決策局及隧道費服務商在有需要時可根據你所提供的電子聯絡方式，以手機短訊或電郵向你發出電子通知。舉例說，如你于犯《定額罰款(交通違例事項)條例》(第237章)下的交通違例事項或《定額罰款(刑事訴訟)條例》(第240章)下的交通罪行，香港警務處可透過電子聯絡方式向你發出電子定額罰款通知書及電子繳付定額罰款通知書；當你的車輛通過已實施不停車繳費系統的收費隧道時，若未能以自動繳款方式即時繳付有關隧道費，隧道費服務商可透過電子聯絡方式向你發出電子繳費通知。請注意，經非櫃位方式遞交的申請需時約十個工作天處理，相關系統將於完成處理申請後的一個曆日內按表格提供的資料作出記錄更新。
- (2) 如任何駕駛執照持有人/登記車主曾向運輸署署長提供其姓名、地址、電子聯絡方式或身分證文件有所改變，他/她須在改變出現後72小時內以書面通知運輸署署長，並需提交有關改變的證明。任何人無合理辯解而違反此規定，即屬犯罪，一經定罪，可處第1級罰款。如屬姓名的改變或身分證文件的改變，他/她亦須將現時持有的駕駛執照、駕駛教師執照、車輛登記文件、車輛牌照及自訂登記號碼分配證明書的正本送交運輸署署長，以作修改。
- (3) 如車輛登記文件及車輛牌照內記載的事項(例如顏色、引擎號碼等)有任何改變，登記車主須把已填妥的運輸署表格 TD559，連同表格內所註明的文件，將有關改變通知運輸署署長。如你的車輛牌照已遺失或損毀，登記車主可向運輸署遞交已填妥的運輸署表格 TD151 申請車輛牌照複本。登記車主須在車輛上展示新的車輛牌照並確保牌照有效，方可在道路上使用該車輛。
- (4) 運輸署署長在處理牌照申請時，可要求申請人出示其現時地址的證明，以及可在申請人出示該等證明之前，暫停處理該申請。因此，請申請人士帶同現時地址的證明，並在牌照事務處人員要求下，出示其地址證明。
- (5) 如你在此申請書內填報的地址及/或電子聯絡方式與本署以你的身分證文件號碼/公司註冊證號碼/公司編號登記的車輛牌照或駕駛執照的記錄有所不同，本署會根據此申請書內填報的資料同時更改有關紀錄，包括按《道路交通(車輛登記及領牌)規例》(第374E章)和《道路交通(駕駛執照)規例》(第374B章)備存的「電子聯絡方式」，及載於《道路交通(駕駛執照)規例》(第374B章)第39條下訂明的「駕駛執照及許可證的紀錄」以及《道路交通(車輛登記及領牌)規例》(第374E章)第4條下訂明的「車輛登記冊」內的地址。
- (6) 你可於現有的牌照屆滿日期前四個月內申請續領車輛牌照，新牌照將於現有牌照屆滿日期起生效。
- (7) 所有在發牌日期前六年或六年以上製造的私家車、所有貨車、的士、巴士、小型巴士、特別用途車輛及拖車，在續領車輛牌照前每年均須接受檢驗。如要查詢現時需要接受檢查的私家車的出廠年份，可致電顧客服務熱線 2804 2600 / 1823 電話中心、向本署各牌照事務處詢問處查詢，或瀏覽運輸署網頁 ([www.td.gov.hk](http://www.td.gov.hk))。
- (8) 如果申請由代理人遞交，代理人必須同時出示其本人的身分證文件正本，以作記錄。
- (9) 除非你能提出充分證據，證明車輛在整段未領牌照的期間內未曾在道路上使用，否則由原有牌照屆滿日期起至新牌照生效日止的期間必須繳交附加費，按每日加收一年應付牌照百分之零點三計算(不足一角，亦以一角計算)。繳交未續領車輛牌照期內的附加費，並不能視作該車已補領牌照，在此情況下發出的新牌照，將由簽發日生效。若有法庭命令指示運輸署署長拒絕向你簽發車輛牌照，則運輸署署長無權向你簽發有關牌照。
- (10) 有關申領駕駛執照、車輛牌照或車輛過戶的申請，如申請人曾以支票支付未繳付的交通罰款，運輸署會在支票付款日七個工作天後，才辦理有關申請。
- (11) 任何人(包括登記車主及司機)在道路上使用汽車，有責任確保有關汽車已購備有一份有效的第三者風險保險單。假如有關人士違反此規定，即屬犯罪，可被處罰款10,000元及監禁12個月；而其持有或領取駕駛執照的資格亦會被取消(由12個月至3年不等)。運輸署署長可拒絕發出有關車輛牌照或取消該車輛牌照。
- (12) 本署不會為已解散的公司辦理任何牌照申請。你可以在公司註冊處網上查冊中心 ([www.icris.cr.gov.hk](http://www.icris.cr.gov.hk)) 查閱已在香港註冊公司的現況，以確保有關公司仍在公司註冊處的公司登記冊上。
- (13) 為確保郵件能妥善送達本署，並免卻不必要的派遞延誤或失誤，請切記投寄郵件前支付足額郵資[請參閱香港郵政有關郵費的最新詳情]。本署不會接收郵資不足的郵件。若郵件郵資不足，有關郵件將由香港郵政處理，當中包括但不限於向有註明回郵地址的寄件人徵收附加費。
- (14) 如登記車主需申請車輛牌照，可透過「易通行」網頁 ([hketoll.gov.hk](http://hketoll.gov.hk)) 或流動應用程式遞交申請，或親身前往「易通行」客戶服務中心或服務點辦理申請手續。
- (15) 在完成辦理你的申請後，你所提交的證明文件副本將會被銷毀。

- (1) E-Contact Means - Applicants must provide either a Hong Kong mobile phone number through which they can be contacted by an SMS message or an email address through which they can be contacted by an electronic mail as the e-contact means when submitting driving or vehicle licensing applications. The e-contact means must be verified through the website of the Transport Department within three months before submitting an application, otherwise the processing of the application may be suspended. For details, please refer to the website of the Transport Department ([www.td.gov.hk](http://www.td.gov.hk)). If both Hong Kong mobile phone number and email address are provided, the Hong Kong mobile phone number would be given priority as the means for issuing electronic notification. Please refer to the "Notes About Your Personal Data" for the purposes of collecting e-contact means and the class of transferees. In particular, the Transport Department, Hong Kong Police Force, other Government departments, bureaux and Toll Service Provider may issue electronic notification to you through the e-contact means provided by you, either by SMS or email, as and when necessary. For instance, an Electronic Fixed Penalty Notice and Electronic Demand Notice may be issued by the Hong Kong Police Force to you through the e-contact means if you commit a traffic contravention under the Fixed Penalty (Traffic Contraventions) Ordinance (Cap. 237) or traffic offence under the Fixed Penalty (Criminal Proceedings) Ordinance (Cap. 240); a toll payment notification may be issued by the Toll Service Provider to you through the e-contact means when the toll cannot be successfully paid by automated payment means where your vehicle passes through a tunnel implemented with Free-Flow Tolling System. Please note that non-counter application takes about 10 working days for processing. The relevant systems would update your record according to the information provided in this form within one calendar day upon complete processing of the application.
- (2) If a change occurs in the name, address, e-contact means or identity document of a driving licence holder/registered vehicle owner previously provided to the Commissioner for Transport, he or she shall, within 72 hours of the change, notify the Commissioner for Transport in writing with the proof of change. Any person who without reasonable excuse contravenes such requirement commits an offence and is liable on conviction to a fine at level 1. For cases of change of name or change of identity document, he or she shall also deliver to the Commissioner for Transport the following documents for amendment, including original copy of the existing driving licence, driving instructor's licence, vehicle registration document, vehicle licence and Certificate of Allocation of Personalized Registration Mark, if applicable.
- (3) If there is change of any entry in the registration document and vehicle licence relating to the vehicle (e.g. colour, engine no. etc.), the registered vehicle owner must submit a duly completed Transport Department Form TD559 together with the required documents stated in the form to notify the Commissioner for Transport of such change. If the vehicle licence is lost or defaced, the registered owner may submit a duly completed Transport Department Form TD151 to the Transport Department to apply for a duplicate vehicle licence. The registered owner must display the new vehicle licence on the vehicle and ensure the licence is valid for using the vehicle on road.
- (4) The Commissioner for Transport may, in processing licensing application, require the applicant to produce **proof of his/her present address**, and **may suspend the processing of the application** until the production of such proof. Applicants please bring along your proof of present address for presentation as and when requested by officers of licensing offices.
- (5) If the address and/ or e-contact means provided in this application form is/ are different from the vehicle/driving licence records of the applicant under the same identity document no./ Certificate of Incorporation no./ Company Registration no. held by this Department, we will update all relevant information in our records accordingly, including the e-contact means provided to the Commissioner for Transport in accordance with the Road Traffic (Registration and Licensing of Vehicles) Regulations (Cap. 374E) and the Road Traffic (Driving Licences) Regulations (Cap. 374B) as well as the address contained in the "Record of driving licences and permits" stipulated under regulation 39 of Road Traffic (Driving Licences) Regulations (Cap. 374B) and "Register of vehicles" stipulated under regulation 4 of Road Traffic (Registration and Licensing of Vehicles) Regulations (Cap. 374E).
- (6) You may apply for renewal of a vehicle licence within four months prior to the expiry date of the current licence. The new licence will be valid from the expiry date of the current licence.
- (7) All private cars manufactured not less than 6 years before the date with effect from which the private cars are to be licensed, all goods vehicles, taxis, buses, light buses, special purpose vehicles and trailers are required to undergo **annual** vehicle examination before having its vehicle licence renewed. For enquiry about the year of manufacture of private cars which requires an examination at present, you may call the Customer Service Hotline 2804 2600 / 1823 Call Centre, approach the enquiry counters of the Licensing Offices, or visit Transport Department's website ([www.td.gov.hk](http://www.td.gov.hk)).
- (8) If the application is submitted by an agent, the agent is also required to produce his/her own original identity document for record purpose.
- (9) Additional fee will be payable at the rate of 0.33% of the appropriate annual rate for each day (round up to nearest 10 cents) of any period between the last expiry date and the date when the new licence commences, unless satisfactory proof is produced to the effect that the vehicle was put off the road during the entire unlicensed period. Please be advised that payment of additional fee does not mean that the vehicle will be licensed for the period for which such fee is charged and that any new licence granted under such circumstances will only start from the date of issue.
- (10) The Commissioner for Transport is not empowered to issue any vehicle licence to you if there are any outstanding court orders directing the Commissioner for Transport to refuse to issue the said licence to you.
- (11) If applicant has used cheque to settle payment of outstanding traffic fines, application for issue/renewal of driving/vehicle licence and/or transfer of vehicle ownership would only be processed after 7 working days from the date of cheque payment.
- (12) Any person (including the registered vehicle owner and driver) has the responsibility of ensuring the presence of a valid third party risks insurance policy for the vehicle concerned whilst using it on roads. Person who contravenes such requirement commits an offence and is liable to a fine of \$10,000 and imprisonment for 12 months, and will also be disqualified from holding or obtaining a driving licence (for a period of 12 months to 3 years). The Commissioner for Transport may refuse to license the vehicle concerned or cancel the vehicle licence concerned.
- (13) This Department shall not process any licensing application from a dissolved company. You may search for the status of a company that is registered in Hong Kong at the Companies Registry's Cyber Search Centre ([www.icris.cr.gov.hk](http://www.icris.cr.gov.hk)) to ensure that the related company is still on the register of companies of the Companies Registry.
- (14) For proper delivery of your mail items to this department, and to avoid unnecessary delivery delay or unsuccessful delivery, please ensure your mail items bear sufficient postage before posting [Please note the latest details about postage rates by Hongkong Post]. This department will not receive any underpaid mail items. Any underpaid mail items will be handled by the Hongkong Post, which actions including but not limited to levying a surcharge on the sender for mail item that bears a sender's address.
- (15) Registered vehicle owners may apply for a vehicle tag via HKE Toll's webpage ([hketoll.gov.hk](http://hketoll.gov.hk)) or mobile application, or visit HKE Toll's customer service centers or service outlets to submit the application.
- (16) Copy of your submitted supporting document(s) will be destroyed after processing your application.
