## **SECTION 1 – TRANSPORT INFRASTRUCTURE MAPS**

The existing transport infrastructure as at the end of 1998 is shown in Figures 1 and 2. Major items commissioned in the year of 1998 include the Country Park Section of Route 3 and the Airport Railway.

Figure 3 shows the road infrastructure proposals in the urban area up to year 2011. Major highway projects on the Hong Kong Island include the Central-Wanchai Bypass and the Island Eastern Corridor Link at the proposed reclamation area on the north shore of the Island, and Route 7 which will connect the Central-Wanchai Bypass and Aberdeen. In Kowloon, Hung Hom Bypass is under construction. Hung Hom –Tate’s Cairn Link, Central Kowloon Route and Kai Tak Connector in Central Kowloon are also planned for implementation to provide relief and to cope with the re-development of the old Kai Tak airport site.

The major road infrastructure proposals up to year 2011 in the New Territories and Lantau Island are shown in Figure 4. High capacity strategic links are recommended to serve the expansion of port facilities in Tsing Yi, Stonecutters Island, Tuen Mun, Tseung Kwan O and north Lantau. The proposed Route 10, comprising a north Lantau to Yuen Long section and the Hong Kong – Lantau Link, will connect Lantau to the north-west New Territories and the Hong Kong Island respectively. Access to Sha Tin will also be improved by Route 9 and the widening of Tolo Highway.

Figure 5 shows the major rail infrastructure up to 2011. The Quarry Bay Extension (Quarry Bay to North Point) is now under construction. The project is expected to be completed by the end of 2000. Upon completion, it will relieve the congestion that is rapidly building up at the existing Quarry Bay station. The Tseung Kwan O Extension (Lam Tin to Po Lam) will provide convenient access to the future developments of the new town. Construction work has already commenced and is expected to be completed in December 2002. The construction work of the West Rail Phase 1 (Tuen Mun Town Centre to Yen Chow Street) has also begun. The project is expected to be completed by the end of 2003. It will provide passenger service between Tuen Mun and Western Kowloon. The Extension of East Rail from Hung Hom to Tsim Sha Tsui and Ma On Shan Rail are both under active planning and design stage. The Sheung Shui to Lok Ma Chau Spur Line which was originally part of the West Rail Phase 2 project is now actively being planned for completion in 2004. Upon completion, it will relieve the existing congestion at Lo Wu Station and provide additional capacity to meet future demand for cross boundary services. The figure also shows some of the longer term projects recommended in the Railway Development Strategy. They include the East Kowloon Line (Diamond Hill to Hung Hom), North Hong Kong Island Line, West Rail Phase II – Cross Boundaries Rail together with a freight service from the boundaries to the container port at Kwai Chung and the Kowloon-Canton Railway extension from Tsim Sha Tsui to Yen Chow Street.

## SECTION 2 - TRANSPORT ADMINISTRATION

### TRANSPORT ADVISORY COMMITTEE

#### Terms of Reference

To advise the Chief Executive in Council on transport matters in accordance with the principles set out in the guidance note.

#### Guidance Note

1. The function of Transport Advisory Committee (TAC) is to advise the Chief Executive in Council on broad issues of transport policy with a view to improving the movement of both people and freight.
2. The consideration of transport and traffic proposals and policy in detail is the responsibility of the Standing Conferences on Road Use and on Waterborne Transport. These conferences will function within the framework of agreed government policy.
3. On any matter within its terms of reference, the TAC is free to communicate with members of the public and with any organisation.
4. The TAC may consider financial matters where they directly relate to transport, but it should be borne in mind that responsibility for proposing public expenditure and taxation lies solely with the Administration.
5. The Secretary for Transport will provide a secretariat for the TAC and will be responsible for its administration.
6. The TAC will be free to form sub-committees, to participate in joint committees with other bodies, and to co-opt members for specific purposes. It may organise its work in whatever manner it considers most suitable.
7. The Chief Secretary for Administration may, after consultation with the TAC and the Chief Executive in Council, amend the terms of reference and this guidance note from time to time.

## TRANSPORT TRIBUNAL

### Terms of Reference

The functions of the Transport Tribunal are defined in Sections 7(1), 33(1), 88D(3) and 90(2)(c) of the Road Traffic Ordinance and Regulations 8 and 23 of the Road Traffic (Public Service Vehicles) Regulations. In the exercise of certain licensing powers the decision of the Commissioner for Transport may be reviewed by the Transport Tribunal. The Transport Tribunal is empowered :

- (a) to review a decision of the Commissioner for Transport to refuse to register or license a vehicle or to revoke a licence;
- (b) to decide whether a person convicted of various 'pak pai' offences (illegal car hire) should have his vehicle impounded;
- (c) to review a decision of the Commissioner for Transport to cancel a hire car permit, to refuse to issue a hire car permit, or to attach certain conditions to a hire car permit;
- (d) to review a decision of the Commissioner for Transport to refuse to issue a passenger service licence, or to cancel, suspend or vary the terms of a passenger service licence;
- (e) to review a decision of the Commissioner for Transport to revoke the designation of a car testing centre; and
- (f) to review a decision of the Commissioner for Transport to amend the terms or conditions of a passenger service licence.

2. The Tribunal comprises an unofficial chairman and two unofficial members drawn from a panel as provided for under Section 17 of Road Traffic Ordinance, Cap. 374.

3. The powers of the Transport Tribunal are governed by Section 19 of Road Traffic Ordinance, Cap. 374 whereas the rules of practice and procedure in any hearing before the Transport Tribunal are prescribed by Section 20 of Road Traffic Ordinance, Cap. 374.

### **SECTION 3 - REGISTRATION AND LICENSING OF VEHICLES AND DRIVERS**

This Section provides statistics on the number of vehicles registered and licensed in Hong Kong, drivers and learner drivers, driving tests and taxi licence tenders as compiled by the Licensing Division. The objective of the Licensing Division is to promote orderly regulation of vehicles and drivers.



## **VEHICLE EXAMINATION**

The Vehicle Examination Division seeks to upgrade the safety of vehicles through improved design requirements and correct maintenance. The mandatory vehicle inspection programme includes annual inspection of buses, light buses, taxis and goods vehicles, while private cars are inspected over 6 years old and trailers over 1 year old. From 1 March 1998 onward, all trailers are required to undergo annual inspection.

The mandatory vehicle inspection is carried out by Transport Department and the private sector. There are four Government owned Vehicle Examination Centres which provide inspection services for buses, light buses, taxis, goods vehicles, trailers etc.. Three of the Centres are operated by Government and the other one is operated by the contractor. There are also 23 privately owned designated Car Testing Centres which provide inspection services for private cars and light goods vehicles not exceeding 1.9 tonnes.

The Vehicle Examination Division also provides monitoring work on franchised buses maintenance and conducts spot checks on in-service franchised buses. The Division also assists Police in examining the accident vehicles.

#### **SECTION 4 - ROAD TUNNELS AND TOLL ROADS**

The eleven road tunnels in Hong Kong continue to play an important role in the internal movements of people and goods. The Transport Department owns six road tunnels, namely the Lion Rock Tunnel, Aberdeen Tunnel, Airport Tunnel, Shing Mun Tunnels, Tseung Kwan O Tunnel and Cheung Tsing Tunnel. Cheung Tsing Tunnel, which is an integral part of the Tsing Ma Control Area, was opened to traffic on 22 May 1997. They are managed and operated by three private companies under management contracts.

The other five tunnels, namely the Cross Harbour Tunnel, Eastern Harbour Tunnel, Western Harbour Tunnel, Tate's Cairn Tunnel and Tai Lam Tunnel, were built by the private sector under 'build, operate and transfer' franchises and have been operated by private companies.

## **SECTION 5 - PUBLIC TRANSPORT**

Hong Kong has a diverse multi-modal public transport system, comprising an electrified Kowloon-Canton Railway, a Mass Transit Railway, the Airport Railway, a Light Rail Transit, a tramway, franchised buses, public light buses, taxis, residents' services, a funicular cable tramway and ferry services, extending to almost every part of the territory. The opening of the new airport at Chek Lap Kok in July 1998 marked a new era for Hong Kong. The new Airport Railway operates to link Hong Kong's new airport and Lantau Island, with Kowloon and Hong Kong Island. New franchised bus services are also operating to the new airport. 1 September 1998 also marked a breakthrough in bus service provision in Hong Kong. It was the first time that an incumbent bus operator lost its franchise. New World First Bus replaced the China Motor Bus Company after having awarded a franchise to operate 88 Hong Kong Island and cross harbour bus routes. It is the government policy to promote healthy competition whilst maintaining a safe, comprehensive and efficient public transport network, offering the public a good range of choices in terms of modes, fares, comfort and convenience. In 1998, the public transport services carried about 10.75 million passengers per day, a decrease of 1.0% over the previous year. While franchised buses experienced an increase of about 0.4% in patronage over the previous year, railway and ferry services, however, suffered a decline of about 2.2% and 12.4% in patronage respectively during the same period.

All trams in (a) and (b) also received new larger rear staircases in preparation for conversion to Pay-As-You-Enter operation during 1999.

The “Star” Ferry Company was incorporated in 1898 and continued services which had begun in 1890. The Company is now a subsidiary of The Wharf (Holdings) Limited.

With the replacement of the “Star” Ferry Company (Services) Ordinance by the Ferry Services Ordinance, Cap. 104 in June 1982, the company’s ferry operations are now controlled by a franchise granted under section 6 of the Ferry Services Ordinance.

## **SECTION 6 - VEHICLE PARKING**

On-street parking is allowed where traffic conditions permit. The use of 15,197 spaces (as at 31 December 1998) was regulated by meters. The management and operation of these metered parking spaces were performed by a private company under a management contract.

Coin-operated mechanical meters were first introduced to Hong Kong about 30 years ago. Most of these meters are now coming to the end of their useful life. In view of this, Transport Department has planned a programme to replace all mechanical meters with electronic parking devices (EPD) by phases. The first phase of replacement programme involving about 3,500 EPDs was implemented in the busy areas from April to June 1998. The second phase replacement programme to replace the remaining mechanical meters was launched in December 1998 for completion by late 1999.

Apart from those public car parks operated by the private sector, off-street parking is provided in 13 Transport Department multi-storey carparks with a total of 7,482 spaces (as at 31 December 1998) which are managed by two private companies under management contracts. In addition, 106 parking spaces are also provided at the View Point Car Park in the Tsing Ma Control Area which is managed by the operator of Tsing Ma Control Area.

## **SECTION 7 - TRAFFIC ACCIDENTS**

This section provides some general statistics on the road traffic accidents occurred in Hong Kong and the casualties as a result of them. The traffic accident data collected by the Police are coded and stored in a traffic accident database system (TRADS) which is managed by the Road Safety and Standards Division of the Transport Department.

The TRADS is used in the identification of accident blackspots for investigations and remedial measures. The database also serves as an important reference and basis in the formulation of road safety strategies, publicity/education programmes and in the review of road safety legislation and policies.

## **SECTION 8 – CONCERN OVER ENVIRONMENT**

Environmental considerations are playing an increasing role in Transport Department's planning and provision of transport infrastructure. The Third Comprehensive Transport Study (CTS-3), which is scheduled for completion in 1999, includes a Strategic Environmental Assessment (SEA) whilst our District Traffic Studies now include a requirement for Environmental Reviews (ER).

In terms of traffic management, our proposals to expand the Area Traffic Control System, and improve the control and surveillance systems on our strategic road network, are examples of how we intend to ensure that the traffic using our roads is doing so as efficiently and therefore as environmentally friendly as possible whilst we intend to reduce the volume of traffic on the roads with such incentives as park and ride. We are also examining the scope for the introduction of pedestrianization schemes, to improve the environment for pedestrians in those areas.

Transport Department, together with the Environmental Protection Department (EPD), continues to closely monitor the air quality inside Government and private tunnels, as well as the covered bus terminals. Advice and assistance are provided to EPD on schemes to reduce emission from motor vehicles. Apart from the normal smoke test for all diesel vehicles, during the annual vehicle examination, an enhanced test involving checking of air filter and engine speed has also been applied to 10% of these vehicles, on a random basis, starting from late 1997. EPD in conjunction with the Transport Department, plans to progressively use chassis dynamometer for measuring emission from vehicles not exceeding 5.5 tonnes, starting from September 1999. Also under consideration is the feasibility of requiring the franchised bus companies to install diesel catalyts on buses.

The one year trial of liquefied petroleum gas (LPG) taxis, also organized by EPD with the assistance of Transport Department, was concluded in November 1998 and based on the findings it is proposed to require all vehicles newly registered as taxis from the end of 2000 to use LPG and to encourage all diesel taxis to be replaced with LPG taxis before the end of 2005.
